The details you submit will be passed onto, and held securely by CBKA, the BBKA, BDI and National Bee Unit(NBU) (where appropriate), and only to third parties who work on behalf of CBKA. They will be used **only** to manage your membership, inform you of the Association’s activities, to alert you to disease threats and give you beekeeping advice. BeeBase is used by the NBU to manage their bee health and inspection services. It is in every beekeeper’s interest to be registered on BeeBase.

**INFORMATION ABOUT MEMBERSHIP CLASSES**

**REGISTERED MEMBER:-** includes 3<sup>rd</sup> party public liability insurance and product liability insurance for claims up to £10m, foul brood insurance for up to 3 colonies (more colonies can be covered – see below) and registration with the British Beekeepers Association. The BBKA sends out a monthly newsletter to all members and produces leaflets and educational packs on various aspects of beekeeping. The Cheshire Beekeeper Magazine is available bi-monthly on the CBKA website or circulated as a hard copy if required. E-News issued via e-mail. Annual fee £30.

**PARTNER MEMBER:-** Full benefits as above, but without separate BDI cover and mailings from the BBKA or Cheshire BKA. This member must reside at the same address as a registered member. Annual fee £20.

**COUNTRY MEMBER:-** BBKA and Cheshire BKA newsletters as Registered Member (above) but no insurance. This category is for people who do not (yet) have bees but wish to be kept informed of the BBKA and Cheshire BKA activities. Annual fee £20.

**FRIEND OF CHESHIRE BEEKEEPERS:-** For non-beekeepers who wish to support Cheshire BKA (no insurance). The Cheshire Beekeeper Magazine is available bi-monthly on the CBKA website or circulated as a hard copy if required. E-News issued via e-mail. Annual fee £10.

**ASSOCIATE MEMBER:-** No insurance cover, no BBKA newsletters and no correspondence. Restricted to the non-beekeeping wife/husband/partner of any of the above members. Cheshire Beekeeper Magazine is available bi-monthly on the CBKA website. Annual fee £5.

**JUNIOR MEMBER:-** Up to and including the age of 17 years. No insurance cover, Cheshire BKA newsletters or correspondence. Cheshire Beekeeper Magazine is available bi-monthly on the CBKA website. Annual fee £7.

**BEE DISEASE INSURANCE**

**ALL COLONIES MUST BE COVERED.** Where, at the time of an inspection by a duly authorised Bee Inspector, the number of colonies managed exceeds the number of colonies for which a subscription has been paid, no cover will apply. N.B. There is no BDI cover provided for Partner members so all colonies must be covered by the Registered member.

**Period of Cover**

Subscriptions and additional premiums are paid in respect of the calendar year, 1<sup>st</sup> January to 31<sup>st</sup> December, irrespective of the date on which they are actually paid. However, cover will not commence until 40 days have elapsed from the payment where such payment is paid after the 31<sup>st</sup> March. This is known as the 40-day Rule.

**For all information refer to the BDI Certificate of membership issued by the Association.**

The first three colonies for each member are covered in the Association subscription. Members can insure more colonies for the following **additional** premiums: -
